

American Farm Bureau Polling Presentation July 26, 2017

Key Points

- Voters overwhelmingly say passing a tax reform bill should be a top or important priority for Congress
- By a 3-1 margin, voters say U.S. tax system is unfair to farmers
- After learning about tax issues related to agriculture, two in three say farmers should be extended special tax considerations
- When it comes to reforming the tax code, voters especially favorable to family-owned businesses
- And, majorities support AFB priorities, including repealing the estate tax; decreasing capital gains taxes for farmland that is sold to the next generation; allowing farmers to deduct machinery purchases; and allowing farmers to average their income income year-to-year

Methodology:

Morning Consult, on behalf of the American Farm Bureau, conducted an online survey of 1,996 registered voters from July 20 - July 24, 2017. Results from the full survey have a margin of error of +/- 2%.
